CALL TO ORDER Lisa Hillman called the meeting to order at 5:35 p.m. and noted the presence of a quorum for a subcommittee.

NEW BUSINESS:

1. H-NNCSB Request for Temporary Affiliation. H-NNCSB requested permanent affiliation of two facilities and temporary affiliation of additional facilities in Newport News for H-NNCSB's Therapeutic Day Treatment and Outpatient Services programs. These programs had been fully discussed in prior meetings of the LHRC. Due to the rapidly growing demand for these services, it is anticipated that the agency will continue its attempts to meet the needs of the community by maintaining children in the least restrictive educational setting necessary for them to thrive. To lessen the burden on the members of the LHRC by eliminating the need for on-going special sessions for the sole purpose of affiliation, the CSB requests pre-approved temporary affiliation of these programs in the remaining 32 Newport News Schools and learning facilities that have not yet affiliated.

ACTION: A motion was made as follows: "Motion to extend permanent affiliation of H-NNCSB's Therapeutic Day Treatment Program to Enterprise Academy and Crittenden Middle School and Outpatient Services Program to Enterprise Academy, such programs to operate under the Human Rights policies and procedures previously approved by the LHRC for other such programs administered by the H-NNCSB." The motion was seconded and unanimously approved without further discussion.

ACTION: A motion was made as follows: "Motion to extend temporary affiliation of H-NNCSB's Therapeutic Day Treatment and Outpatient Services programs to the 32 Newport News learning facilities/schools that have not yet affiliated, all identified in the attached Exhibit "A"; such programs to operate under the Human Rights policies and procedures previously approved by the LHRC for other such programs administered by the H-NNCSB; the temporary affiliation of a particular program shall be effective the date the H-NNCSB enters into an agreement with a learning facility/school for such program

and shall expire on the date the LHRC next meets for a regularly scheduled meeting; the H-NNCSB shall provide an update of affiliations at each regularly scheduled meeting.” The motion was seconded and unanimously approved without further discussion.

The next regularly scheduled meeting is scheduled for **September 8, 2009** at H-NNCSB, Bldg. 300. at 5:30 p.m.

ADJOURNMENT There being no further business, the meeting was adjourned at 5:51 p.m.
