CALL TO ORDER Lisa O. Hillman called the meeting to order at 5:35 p.m. and noted the presence of a quorum for a subcommittee.

NEW BUSINESS:

H-NNCSB requested permanent affiliation of the remaining 22 Elementary facilities, 5 Middle Schools, 4 High Schools, and 6 Special Learning Centers in Hampton for H-NNCSB's Therapeutic Day Treatment program and outpatient services. Due to the rapidly growing demand for these services, it is anticipated that the agency will continue its attempts to meet the needs of the community by maintaining children in the least restrictive educational setting necessary for them to thrive.

ACTION: A motion was made as follows: "Motion to extend affiliation of H-NNCSB's Therapeutic Day Treatment program to the 37 Hampton learning facilities/schools that have not yet affiliated; such programs to operate under the Human Rights policies and procedures previously approved by the LHRC for other such programs administered by the H-NNCSB; the temporary affiliation of a particular program shall be effective the date the H-NNCSB enters into an agreement with a learning facility/school for such program and shall expire on the date the LHRC next meets for a regularly scheduled meeting; the H-NNCSB shall provide an update of affiliations at each regularly scheduled meeting." The motion was seconded and unanimously approved without further discussion.

The next regularly scheduled meeting is scheduled for **December 8, 2009** at H-NNCSB, Bldg. 300.

ADJOURNMENT There being no further business, the meeting was adjourned at 5:51 p.m.
